On Wednesday, December 10th and Thursday, December 11th, the Baton Rouge Police Department Narcotics Division executed several search warrants that ended with multiple arrests and a multitude of seizures. A large amount of narcotics, firearms, currency were seized with the arrest of eleven (11) individuals. This was the culmination of several short term investigations, along with a month long investigation into drug trafficking in the Zion City area.

Below are a list of the seizures and persons arrested. Attached is a photo of some of the seized evidence.
